GYMNASIUM RULES and MEMBERSHIP DECLARATION

These rules are to be considered an addendum to the SLSA Membership Application, the CODE of Conduct of Surf Life Saving Australia, WH & S Guidelines and the Yamba Surf Life Saving Inc. Guidelines for Members. The rules should be read in concert with those conditions and policies.

Fees will be levied with a view to fund repairs and maintenance of existing equipment and the acquisition of new equipment and to assist in the funding of general club needs.

Restricted access to the gymnasium will be monitored and enforced for the safety, comfort and amenity of all paying members. The rules are considered necessary in providing a basis to protect and ensure the longevity of existing equipment and self funding for future maintenance, improvements and equipment acquisition.

1) GYM MEMBERSHIP:

- a. Gymnasium membership fees will be set by the committee at the time fees for all membership categories are determined for the coming financial year. The membership year is July 1- June 30
- b. Upon payment of such fees and acceptance by the club gymnasium members will be issued with a membership card endorsed with name, Registrar’s signature and period of membership. Club keys will also be issued upon request and the number recorded. A key deposit is required.
- c. Gymnasium membership is not transferable and affords access and use of the gymnasium to the nominated member only.
- d. Gymnasium fees are not refundable in the case of voluntary termination or cancellation.
- e. The use of the gymnasium and equipment is at the members own risk and users are required to indemnify the Yamba Surf Life Saving Inc. accordingly.

ELIGIBILITY:

- f. Gymnasium membership and use is only available to those Yamba Surf Club members who are the holder of associate membership (must be over the age of 25) or who are active patrolling club members (or Life Members) who have reached the age of 14 years. Gym use for members under the age of 14 is not permitted.

2) GYMNASIUM ACCESS AND USE:

- a. Only those persons holding current paid club AND gymnasium membership for the financial year (or part thereof) are permitted to access and use the gymnasium area and equipment contained therein.
- b. Members are to observe the current gymnasium hours of operation and club access hours.
- c. Members are required to carry their gymnasium membership card at all times when using the gymnasium and produce it on demand. This rule is to ensure currency of membership and that access by unauthorized persons is limited. All Club Board Members are deemed gymnasium stewards.
- d. Gymnasium members are not permitted to invite or provide access to the gymnasium, on an ongoing basis, to persons who are ineligible under Rule 2 (a) or who are non-financial gymnasium members.
- e. Gymnasium users are required to enter their name in the gymnasium register on all occasions they access and use the gymnasium.
- f. Those persons failing to provide proof of membership may be asked to leave immediately.
- g. A towel must be carried and used on all equipment.
- h. Shoes and shirt must be used when training.
- i. Food is not to be taken into or consumed in the gymnasium area.
- j. All members are required to keep the gymnasium clean and tidy and return all equipment to racks and storage location upon completion of workout. Gym and clubhouse to be locked after use.
- k. Damaged or broken equipment should be reported immediately to the Club Board members or House Committee either personally or in the gymnasium register book.
- l. All members will be provided with a copy of these rules and are required to acknowledge by signature acceptance of these rules associated with gymnasium membership. Gymnasium membership will not be preferred without the acceptance of these rules.

3) JUDICIARY COMMITTEE REFERRALS:

- a. A gymnasium member failing to adhere to any rule may be required to appear before the Board (Judiciary) to show cause as to why the gymnasium membership should not be subject to sanction or cancellation.
- b. The Board may administer any sanction or penalty it sees fit.
- c. The Board may only issue one warning in any Financial Year for a breach under rule 3(c). Cancellation of gymnasium membership for a breach under this rule will be for the remainder of the Financial Year.
- d. The decisions and deliberation of the Board on disciplinary matters will be administered as per the rules of the Yamba Surf Life Saving Club Inc.

DECLARATION

- I have read and acknowledge the rules and conditions contained on this document regarding access and use of the Yamba Surf Life Saving Club Gymnasium.
- I acknowledge and understand I may be liable for sanction or cancellation of gymnasium membership should I fail to comply with these rules and conditions.
- I accept that I access and use the gymnasium and equipment at my own risk.
- I acknowledge that Yamba Surf Life Saving Club Inc. will take all reasonable steps to ensure all equipment is operating as designed and is in good repair however I undertake to inspect all equipment prior to use and will refrain from using any damaged or broken equipment.
- I undertake to operate all equipment as it is intended to be used.
- I undertake to report immediately any damaged or broken equipment as required by these rules.
- I absolve Yamba Surf Life Saving Club Inc. of any responsibility should I misuse the gymnasium, gymnasium equipment or fail to educate myself in the proper use of the equipment prior to use.
